Committee Reports:

<u>Finance – Ryan Miller</u>

We are finishing 2024 in the black, draft unaudited results are: 2024 Net Income \$55k vs \$88k in 2023.

Today we hold \$130k++ in the Main Operating account, \$13k in Charity, \$23k in VLT. We have \$100k in a GIC that matures in April.

Question: What is the plan for GIC funds?

Some funds are expected to remain invested for emergency or business continuity purposes. The 2025 financial plans will consider big capital projects and our operating spending to determine how much and for what term funds should be invested. Currently we have \$100k non-redeem GIC at 4.05% due April 9 Question: What is status of Accessible Washroom grant application? No change from the Under Assessment status.

Facilities – Rick Squires

Recent activity included: kitchen fire suppression inspected today, Fireplace Lounge walls have been repainted in a brickwork theme, Internet access (wifi) has been upgraded with installation of devices in the main hall and basement

Question: What is status of refrigerated storage and ventilation fan for the bar area?

Last year \$15,000 was budgeted for used equipment. That would be a starting point for accomplishing this item this year and work should be scheduled soon in advance of warm summer weather.


